21/006 Student Numbers 2021/22 - Update

Healthy enrolment: a total of 1,470 students were enrolled (expecting a loss of

approx. 80 by census date).

It was noted that numbers are in line with the forecasted budget (1,350), noting also

lagged funding (i.e. 2022/23). The College is at full capacity.

The enrolment process will be reviewed at the next meeting of the Curriculum & Standards Committee (21 September 2021).

The Committee noted the update on student numbers 2021/22.

21/007 Property Strategy - Update

- i) The T Level Bid (£1.8m) has been approved in principle. The letter of comfort from the Diocese and additional information was submitted to the ESFA by the deadline.
- ii) A decision is awaited for the DfE Capital Growth (Post-16) Bid (£4m) the timing of this was pushed back from summer to autumn. The completion date stated for works was August 2022.
- iii) A full application has been submitted to planning for all phases of the project and the consultation period has lapsed.
- iv) A meeting with AHR will be arranged shortly (Principal/DFO).
- v) The Committee were updated on an approach made to ND by St Anne's (St Mark's Avenue). A meeting with St Anne's will be arranged towards the end of September (Principal/DFO).
- vi) The property strategy / update was discussed with the Diocese at a Contact Group meeting held on 9 September 2021.

The Committee noted the property strategy update.
