The Clerk reported on nominations received for:

#### 21/008 Catholic Life - enclosed

provided an overview of the Catholic Life report which includes updates on:

- i) Stella Maris Leadership Award: 812 L6 students achieved the Bronze Stella Maris Award in summer 2021.
- ii) Developing student leadership in collective worship: Faith Officer on Student Executive supporting Lay Chaplain to develop collective worship in assembly and tutorial prayer.
- iii) The Leeds Diocesan Singing Programme: choir enhancement in support of wellbeing and to help with the liturgical life of the College.
- iv) Wider faith prayer opportunities: prayer space provided for our Muslim students.
- v) Service / volunteering opportunities: Director of Catholic Life working with the Careers Department to support this provision.
- vi) CPD for Achievement Tutors: on collective worship, introducing the 'Still and Silent Moment' and how to support the Stella Maris Award.
- vii) Twinning with another Notre Dame school: awaiting confirmation of this, possibly an ND school in Japan or the USA.
- viii) Developing the Credo Programme for PTE: using 'Thinking Moves' to provide a vocabulary and giving a means to work on improving the effectiveness of student thinking.
- ix) Department charities: mapped to Catholic Social Teaching.
- x) PTE curriculum intent, assessment intent and implementation: in line with the most recent published details of the new RECD (Religious Education Curriculum Director); see report for details.
- xi) Fr. Tim met with CH last week; very pleased with initiative to enhance student engagement with collective worship.
- xii) Thanks were noted to CH.

Q: Over the assessment for Stella Maris.

A: The Principal explained the process and monitoring with use of student logbooks. Moderation undertaken is by the PTE department (previous external support from Leeds Trinity).

## **21/010** Report of the Staff Governor - enclosed

The Staff Governor provided an overview of the report which includes updates on:

- i) A Level Business: ND+; utilisation of Microsoft OneNote; Year 12 induction activities.
- ii) Careers: support provided on GCSE and A level results days and throughout enrolment; support to local partner schools; Volunteering stand at Enrichment Fair; wide range of employer meetings held by T Level Employer Engagement Lead to source T Level placements.
- iii) Religious Studies: name change to 'Philosophy, Ethics and Religious Studies'; speakers / links / Instagram account; recruitment up 24%.
- iv) Psychology: student numbers (331 students enrolled compared to 220 last year); ND+; Couch to 5k; planned trips to Chester Zoo and London; member of department is an ECT Mentor.
- v) Health & Social Care: partnership working for new Health T Level qualification; placements; new simulation room.
- vi) Classics: social event; Cafod appeal; Greek language enhancement.
- vii) PE and Sports Teams: various successful trials with good attendance; aim to have a rugby league team this year.
- viii) Other: new popular canteen menu; departmental student socials.

Q: T Levels – how many students are there?

A: Number of students in Leeds: 18 at ND, LCC 15-20. NC noted fantastic achievement on ND's student numbers for T Levels. noted the confidence in the Health Care Academy – this is due to be launched in other cities; it works well for T Level Health due to the size of the NHS.

Q: Are there clear pathways?

A: Yes, e.g. midwifery.
